- This in-person course is conducted under the auspices of the Singapore Cooperation Programme Training Award and is one of the courses offered under the Sustainability Action Package.
- This course will discuss Singapore's approach to integrated water resource management to manage the effects of extreme weather conditions brought on by climate change for a sustainable future.
