Subject: **TRAINING COURSE ON "GENDER MAINSTREAMING FOR SOCIO-ECONOMIC DEVELOPMENT" FROM OCTOBER 21- 25, 2024.**

Akhtar Hameed Khan National Centre for Rural Development (AHKNCRD) is an Executive Department of the Establishment Division, responsible for promoting awareness on different issues impacting on rural development in Pakistan, through its programmes of capacity building and research. Training is imparted, inter alia, to elected councilors, officials of the Local Government and Rural Development Departments, functionaries of Nation Building Departments (NBDs) including women functionaries and NGOs to improve their professional skill and promote sharing of experiences.

2. AHKNCRD is planning to organize a five days' training course on "Gender Mainstreaming for Socio-economic Development" from 21st - 25th October, 2024. The major objectives of the training course include:

- To acquaint the participants with the concept of Gender Mainstreaming and its impact on Development;
- To familiarize the participants with the different aspects of women empowerment and Government initiatives in this regard;
- Provide a forum for sharing of experiences in promoting Gender Mainstreaming for Development.

3. No training fee will be charged for the training; however, TA/DA of the participants shall be borne by the nominating agencies. Boarding and lodging facilities are available in the NCRD Hostel located within NCRD Complex, on the approved rates on double occupancy basis. Food expenses will be borne by the participants and staff is available in the Hostel for necessary services.

4. Participants may please be informed that Family Members/Servants are not allowed to stay with them in the Hostel.


